Election Reports Types

Voter List – List of voters countywide, or by district or precinct. List includes full name, residence address, mailing address, political party preference, phone number, email, registration date, and vote by mail status.

Voting History – Secondary file to the Voter List includes the Election name for all Shasta County elections that the voter voted a ballot. Up to five specific elections can be chosen.

Candidates – List of persons that filed official documents to become a candidate.

VBM App Date Range – List of voters by date range selection who have submitted a Vote-by-Mail application to received ballot by mail.

VBM Ballot Tracking – List of voters by date range selection including the status of Vote-by-Mail ballot; sent date, received date, received method, and count status.

FPPC Filing – Financial Disclosure or Economic Interest forms filed by county officials and candidates.

Polling Place List – List of polling locations; specific to election.

Consolidated Precincts – Specific to an election; the list of precincts combined for polling location and ballot type purposes.

District / Precinct List – District and precinct cross-reference.
