We demand an election of a successor to that office. The following Notice of Intention to circulate a recall petition was served on April 30, 2021 to Mary Rickert.

The grounds for the proposed recall are as follows: Removing Mary Rickert is a course correction for Shasta County. 1) She has betrayed public trust. She didn't defend our county from state government overreach. She bowed to Governor Newsom, a lawless politician, for county funding. She capitulated to the State and refused to take local control. She failed to fulfill her oath to secure our right to choose safety for ourselves. As Chair in 2020 she proved herself incompetent; closed chambers to the public, failed to schedule a vote to open the county, and failed to accommodate regular evening meetings. 2) Need for fundamental change. She has been irresponsible with taxpayer money, directing its use in bloated, inefficient county programs. She approved our Health Officer, Dr. Karen Ramstrom, for a total compensation over \$279,000 alongside an out-sized department with the majority of the county budget, over \$200 million. 3) This is a last resort. We cannot afford to wait until 2024 to elect new representation. This recall is an exposé of Rickert's overt disregard toward community leaders, parents, doctors, nurses, teachers, and experts petitioning for local control. 
